#### Item No I: Time-bound redressal of the Ragging related issues.

- The Convener D&AR shown full of his enthusiasm to deliver the very purpose of this cell, and thanked the Principal in Charge for such an initiative in the best interest of all the Staff and Students.
- The Committee will ensure the time-bound settlement of the issues.

#### Item No. 2: Mechanism of maintaining discipline.

- The task force will maintain and enforce strict discipline within the campus.
- Wearing an Institutional identity card will be compulsory for all students.
- In case of any violation of the dress code or disturbance in the class, the 1D card will be confiscated from the student which will be handed over to the student on the same day with a warning and advice from the D&AR committee members
- In case of any misbehaviour or violation of the college rules, the ID cards of the students will be kept with the Disciplinary Committee Members till the inquiry is over.
- The committee will ensure the total prohibition of cell phone usage by the students in the classroom.

- To monitor the movement of the students in the college and prevent students loitering around in the corridors during the college working hours.
- To ensure that students maintain complete silence in the library
- To maintain proper discipline in the college canteen and student waiting room during the college working hours.
- If any damage is caused to the institute property by any student/group of students, the
  cost of the same may be recovered with a fine from the said student/group of the
  students followed by disciplinary action.
- If any indiscipline is found by any of the students, the warning will be given to them
  in the first instance. In case of a continuation of the misconduct, the committee may
  take disciplinary action.

## Item No. 3: Miscellaneous by the permission of the chair.

- Political activities and the functioning of the student organizations are strictly banned in the campus. Unofficial meetings, strikes, demonstrations, agitations, and fund collection are strictly prohibited. Students who violate the above rules are liable to be dismissed from the college summarily.
- No student shall bring in to the institution campus any banner, flag, board, notice pamphlet, or any other such materials for the purpose of any the political activity of student organizations or other organizations.
- Students should not go outside the campus during class hours. In the event of unavoidable necessity they should seek special permission of the Principal/ Head of the Department.
- Smoking or chewing tobacco on the campus is banned. Anyone found guilt will be viewed seriously.

- c) Suspension with loss of pay and / or allowance (For a period of not more than one month). Service Conduct Rules of Government of Tripura is applicable for employees of this Institution.
- d) Stoppage of candidature.
- e) Rusticate from the Institution.
