The meeting of S/C/S/T/OBE committee held on 13th June on Monday.

The committee arrived at the following below mentioned decisions

1. Remedial coaching is to be organized at postgraduate level
2. Improve the academic skills and linguistic proficiency of the students in various subjects.
3. To raise their level of comprehension of basic subjects to provide a stronger foundation for further academic work.
4. To strengthen their knowledge, skills and attitudes in such subjects; where quantitative and qualitative techniques and laboratory activities are involved so that the necessary guidance and training provided under the programme may enable the students to come up to the level necessary for pursuing higher studies efficiently and to reduce their failure and dropout rate.
5. To provide career guidance and psychological counseling for capacity building to those who are in need of such counseling.
6. Applications may be invited and selection of candidates for providing coaching will be done from the regular as well as dropped out students.
7. Coaching classes may be organized at different times such as during working, or on holidays or in vacations depending on the common convenience of the candidates as well as faculty members.

vacations may be utilized for admitting candidates from other universities. The timetable of coaching classes should be announced in the beginning of the classes.

- The method of instruction should be through class work, tutorials, work assignments followed by discussion and face to face interactions. candidates should be encouraged to form study groups to help one another. Audio-video aids should be used wherever possible. A great deal of voluntary effort should be promoted.
